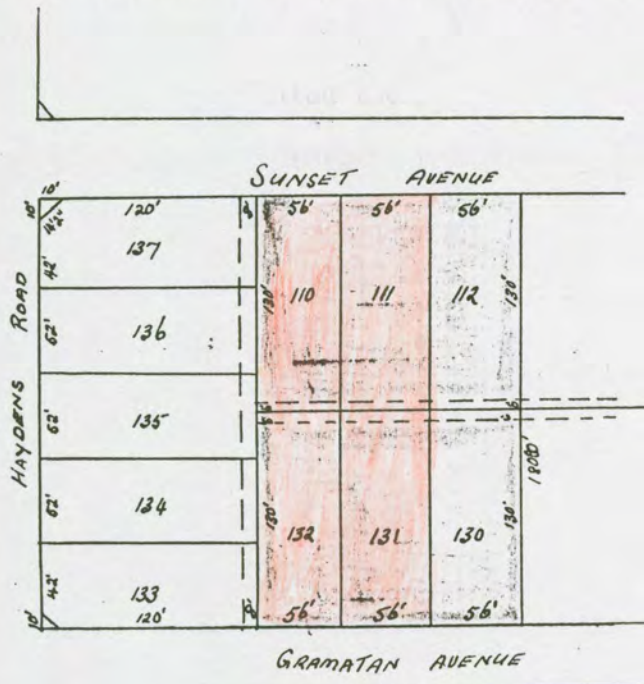

THAT piece of land delineated and colored red on the map drawn in the margin hereof to be held by the Lessees for the purpose herein specified for a term of seven years as from the first day of ---- November One thousand nine hundred and fifty-eight at a clear ---- yearly rent of <sup>Five</sup> ~~seventy-five~~ Pounds payable by equal monthly payments ~~of Six Pounds Five Shillings on the first day of each and every~~
