MINUTES OF THE 68TH ANNUAL GENERAL MEETING OF BEAUMARIS CONSERVATION SOCIETY INC., HELD ONLINE VIA 'ZOOM', OWING TO THE COVID-19 PANDEMIC, ON WEDNESDAY, 02 DECEMBER 2020

6. DISCUSSION ON MATTERS BRADLEY ROWSWELL MLA ASKED TO SPEAK TO:

B Rowswell referred to his letter to Hon. Lily D'Ambrosio, Minister for Energy, Environment and Climate Change, asking her for supervision of the Ricketts Point Marine Sanctuary to be greatly improved, in order to prevent the frequent illegal fishing within it. It was noted that her reply (Ref. MIN081579, 2020-11-25) said power boats were permitted within the Sanctuary provided that they moved no faster than 5 knots, but she made no mention of the substantial No Boating Zone at Watkins Bay. Speakers - including P Corfield, V Mosk and G Goode - supported the points Brad made, such as extending the boundaries of the Sanctuary, and the benefit of increasing the area of the No Boating Zone within the Sanctuary, which should reduce illegal fishing, and the general nuisance and danger from jet skis. Increasing adverse impact on the Sanctuary's amenity from boisterous partying groups arriving *en masse* from elsewhere was noted.
